Calculation formula for assigning the final grade:
Final classification = (Pedagogical activity*0.40) + (Technical-scientific activity*0,3) + (Organizational activity*0,3)
In the event of a tie, the following tiebreaker criteria are used successively:

- Have seniority as a teacher or equivalent to a full-lime or invited teacher or exclusivity in Higher Education, in the area for which the competition is open;
 Have completed a doctoral degree or specialist title longer.
